**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
JODICO OF TAMPA, INC.**

CHANGING CORPORATE NAME

Pursuant to the provisions of Sections 607.1001, 607.1005 and 607.1006, Florida Statutes, the undersigned corporation, **JODICO OF TAMPA, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to amend its Articles of Incorporation to change its corporate name:

1. **Name of the Corporation.** The name of the Corporation is Jodico of Tampa, Inc. and its Florida document number is P00000049626.
2. **Text of the Amendment.** The amendment is to change the Corporation's corporate name. Accordingly, Article I of the Articles of Incorporation is amended in its entirety to read as follows:

ARTICLE I.

Name

The name of the Corporation is **Signs Now Holdings Corp.**

3. **Date of Adoption.** The Amendment was adopted November 7, 2002.
4. **Manner of Adoption.** The Amendment was adopted by the unanimous written consent of all the members of the Board of Directors of the Corporation prior to issuance of any shares.
