ARTICLES OF INCORPORATION

OF

ARTICLE I: Name.

The name of this corporation is INTERACTIVE COMMUNICATION AND ALARM SYSTEMS, INC.

ARTICLE II: Duration.

This corporation shall exist perpetually.

ARTICLE III: Purpose.

This corporation is organized for the following purpose: To transact any and all lawful business authorized under the Statutes of the State of Florida.

ARTICLE IV: Capital Stock.

This corporation is authorized to issue seven thousand, five hundred (7,500) shares of Common Stock having a par value of one (\$1.00) dollar per share.

ARTICLE V: Pre-emptive Rights.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI: Initial Registered Agent and Office.

ARTICLE VII: Initial Board of Directors.

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one (1). The name and address of the initial director of this corporation is:
