# ARTICLES OF INCORPORATION OF P/C QUALITY METAL CONSTRUCTION, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I - Name

The name of the corporation is: P/C Quality Metal Construction, Inc.

# ARTICLE II - Principle Office and Mailing Address
