ARTICLES OF INCORPORATION
OF

The undersigned natural person hereby forms a Stock Corporation pursuant to the provisions of Chapter 607 and 621 Florida Statutes and adopts Articles of Incorporation for such Corporation.

ARTICLE I

The Name of the Corporation is VINTAGE '50. INC.

ARTICLE II

The principal place of business and mailing address of the corporation is 1111 Bayshore Blvd., C11, Clearwater, FL 33759.

ARTICLE III

The purposes for which the Corporation is organized are to engage in general information technology business, and in the general practice of technology and architecture as a primary contractor or subcontractor; that the corporation shall also provide services and act as consultants in providing specialized computer systems, feasibility studies, system research and analysis; computer facilities management; the implementation of computer systems and training therefor; the design and development of computer system packages; and to market the product of the Corporation's efforts. In addition the Corporation shall have and exercise any and all powers that corporations have and may exercise under the laws of the State of Florida, and as the same may be amended, except such powers as are inconsistent with the express provisions of these Articles.

ARTICLE IV

The Corporation shall have authority to issue TWO THOUSAND FIVE HUNDRED (2500) shares of Common Stock at the par value of One Dollar (\$1.00) each.

ARTICLE V

The corporation shall have one initial officer who is to serve as president:

ARTICLE VI

The corporation shall exist perpetually.

ARTICLE VII

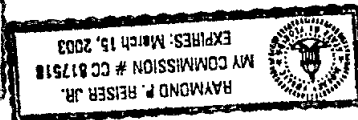
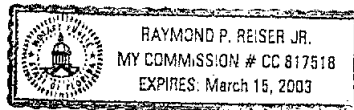
