

ARTICLES OF INCORPORATION OF ADVANCED MEDICAL DATA SYSTEMS, INC.

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator of ?? this corporation for pecuniary profit under the Florida Business Corporation Act.

ARTICLE I NAME AND LOCATION OF AGENT AND OFFICES

- 1.1 Name. The name of the corporation shall be ADVANCED MEDICAL DATA SYSTEMS, INC..
- 1.2 Principal Office and Mailing Address. The corporation's principal office, if known, shall be 6231 AVENTURA DR., SARASOTA, FLORIDA 34241, and the mailing address of the corporation shall be 6231 AVENTURA DR., SARASOTA, FLORIDA 34241.
