### ARTICLES OF INCORPORATION PEKING EAST CHINESE RESTAURANT, INC.

OO MAY 15 PM 3: 2 The undersigned, for the purpose of forming a corporation for profit under the laws Florida, adopts the following Articles of Incorporation:

#### Article I Name

Section 1.1. Name. The name of this corporation shall be Peking East Chinese Restaurant, Inc.

### Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 1101-102 Blanding Boulevard, Orange Park, Florida 32065.

### Article III Capital Stock

Section 3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is Seven Thousand (7,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

The shareholders may, by bylaw provision, by shareholders' agreement recorded in the minute book or by endorsement on each stock certificate, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
