The name of the Corporation shall be:

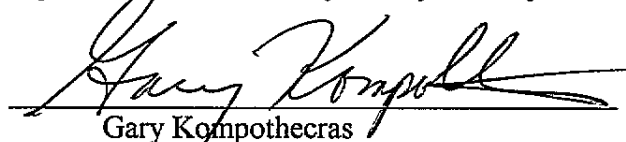
SARASOTA MRI CENTER, INC.
