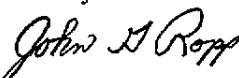

ARTICLE IX – Indemnification

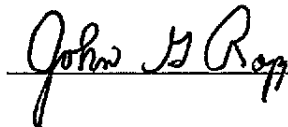
