

# ARTICLES OF INCORPORATION

THE UNDERSIGNED, desiring to incorporate a corporation under the provisions of the Elorida Corporation Act does hereby certify:

- 1. The name of the corporation is HOMESTYLE GUIDE, INC.
- 2. The term for which the corporation is to exist is perpetual.
- 3. The general nature of the business to be transacted by the corporation shall be to engage in any act permitted under the laws of the United States of America and of the State of Florida, as limited by the provisions of the Florida Corporation Act.
- 4. The aggregate number of shares of capital stock which the corporation shall have the authority to issue is five hundred (500) shares of common stock having a par value of one dollar (\$1.00) each.
- 5. The initial principal office of the corporation shall be located at 416 Via De Palmas #81, Boca Raton, FL 33432. Registered Agent shall be BRIAN KATZ.
- 6. The initial Board of Directors shall be comprised of three (3) members. The number of Directors may be either increased or decreased from time to time by the Bylaws but shall never be less than two (2).
