# ARTICLES OF INCORPORATION OF ANN THOMPSON & CO.

#### ARTICLE I - NAME

The name of this corporation is ANN THOMPSON & CO...

### **ARTICLE II - DURATION**

This corporation shall have perpetual existence unless sooner dissolved according to law.
