

ON SATURDAY, 18 OCTOBER 2003, I RECEIVED A CERTIFICATE OF ADMINISTRATIVE DISSOLUTION OR REVOCATION. AFTER CHECKING MY RECORDS I HAVE FOUND THAT I DID NOT RECEIVE THE INITIAL UBR MAILINGS FROM THE STATE. WHEN I DID RECEIVE A NOTICE IN EARLY SEPTEMBER, I FILLED OUT THE UBR FORM AND INCLUDED A LETTER EXPLAINING THAT THE EARLIER UBR FORMS HAD NOT BEEN RECEIVED AND INCLUDED A CHECK FOR THE NORMAL \$150 FILING FEE. THE CHECK HAS POSTED TO MY ACCOUNT.

I SPOKE WITH TOM GEBORA AT THE DIVISION OF CORPORATIONS THIS MORNING, EXPLAINED WHAT HAD TRANSPIRED AND ASKED HIS ADVICE AS TO HOW I SHOULD PROCEED. HE AGREED THAT I HAD FOLLOWED THE REQUIRED PROCEDURES AND SHOULD NOT BE PENALIZED FOR LATE FILING IN THIS CASE. IN ACCORDANCE WITH HIS RECOMMENDATIONS I AM ENCLOSING COPIES OF CHECK # 724 DATED 9 SEPTEMBER 2003 MADE OUT TO THE DEPARTMENT OF STATE, THE BANK STATEMENT SHOWING CHECK #724 POSTED, THE PREVIOUS LETTER OF EXPLANATION DATED 9 SEPTEMBER, THE PREVIOUSLY FILED UBR AND THE APPLICATION FOR REINSTATEMENT.

I BELIEVE, AS DOES MR. GEBORA, THAT I HAVE SATISFIED THE REQUIREMENTS FOR UBR FILING AND REQUEST THAT TVG ENTERPRISES, INC. BE REINSTATED WITHOUT PENALTY.
