**ARTICLE I**  
**CORPORATE NAME AND PRINCIPAL ADDRESS**

**ARTICLE II**

The person named as initial director shall hold office for the first year of existence of this corporation or until a successor is elected or appointed and has qualified, whichever is first.

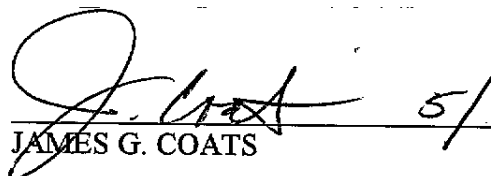
ARTICLE VIII

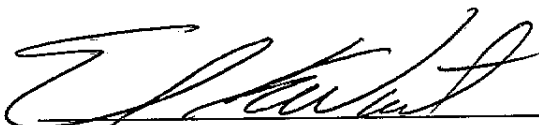

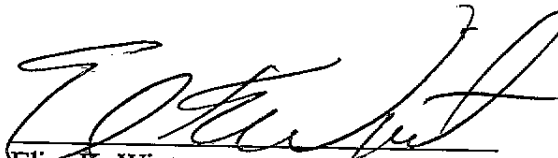
