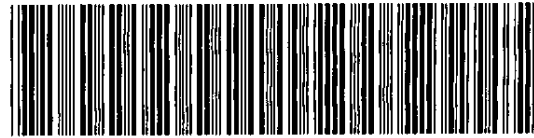

(the "Corporation") was duly organized as a Florida corporation on May 22, 2000, pursuant to Articles of Incorporation which were duly filed with the Florida Secretary of State on that date. Pursuant to the provisions of Section 607.1006, the Articles of Incorporation of the Corporation is hereby amended the name of Article IV and the following definitions listed below in Article IV as follows, without modifying any other provisions of the Articles of Incorporation:

**"ARTICLE IV: DEFINITION OF TERMS**

"Series A Maturity Date" means March 31, 2014.

"Series C Maturity Date" means March 31, 2014."

The undersigned hereby certifies as of the hereof that the foregoing Amendment to the Articles of Incorporation of the Corporation were duly approved and adopted by the unanimous written consent of the Directors of the Corporation and by representatives of a more than 60% in interest of the stockholders of the Corporation and more than 60% in interest of the holders of each of the Series A and Series C Preferred Stock as of March 30, 2012, all in accordance with the Florida Statutes and the Articles and Bylaws of the Corporation.
