Pursuant to our phone conversation on the above date I am forwarding this letter of explanation. There was an apparent mistake in the application for our renewal of the corporation "River Forest Realty Inc." which was caused by the failure to submit the signature form with the check upon submittal.

It appears the reason for the problem was caused by the fact that we did not receive the correspondence mailed at the beginning of the year, which included that form.
