# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CAREER COACHES, INC., A FLORIDA CORPORATION

Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is Career Coaches, Inc. (document number P00000050279).
- 2. Article IV of the Articles of Incorporation of the corporation shall be amended in its entirety to read as follows:

# "ARTICLE IV SHARES

This Corporation is authorized to issue One Hundred Thousand (100,000) shares of common stock, all of which shall be of the par value of One Cent (\$.01) per share."

3. The following Articles of Amendment to Articles of Incorporation was adopted by written consent by the sole member of the Board of Directors, and by a majority of the Shareholders of the Corporation, effective June 30 2003, in the manner prescribed by the Florida Business Corporation Act.
