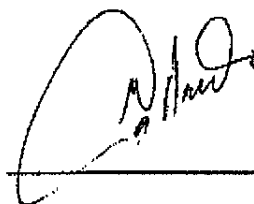
## Bylaws

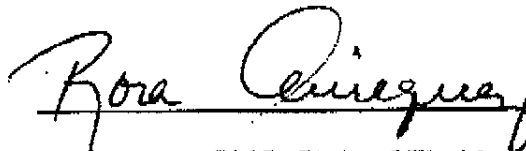

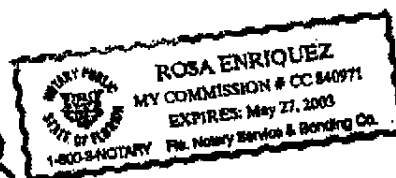
