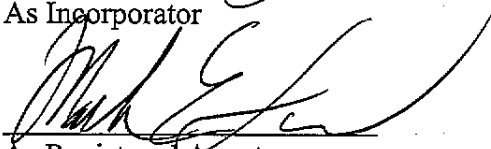
ARTICLE TEN
