ARTICLES OF INCORPORATION

OF

ARTICLE I: CORPORATE NAME



The name of this Corporation is **Duran & Wilter, Inc.**, and its mailing address is, 779 9th Ave. N. # 15, St. Petersburg, FL 33701.

ARTICLE II: NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having par value of one (\$1.00) dollars.
