## ARTICLE I CORPORATE NAME

The name of this corporation is Hot Looks Fashion, Inc.

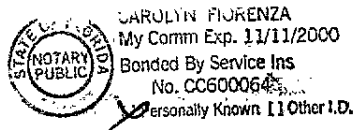
