ARTICLES OF AMENDMENT OF MD DIETS, INC.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of the above-named Corporation hereby amended as follows:

- 1. The name of the Corporation shall remain and be MDDiets, Inc.
- 2. Article IV of the Corporation's Articles of Incorporation is deleted in its entirety, and a new Article IV is hereby adopted, to read as follows:

ARTICLE IV SHARES

The aggregate number of shares which the Corporation is authorized to issue is one million (1,000,000) shares of One Dollar (\$1.00) par value voting capital common stock.

- 3. Except as expressly provided herein, the Corporation's Articles of Incorporation shall be and remain in full force and effect, and its present Registered Agent shall continue to serve in such capacity until his replacement is duly appointed and qualified.
- 4. The amendment set forth above was adopted on November 27, 2001 by the vote of the shareholders holding one hundred percent (100%) of the outstanding voting common stock of the Corporation, and was sufficient under Florida law to effect such amendment.
