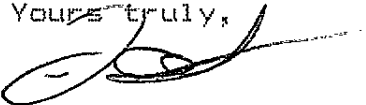

ARTICLES OF INCORPORATION OF  
DNS YACHT SERVICE, INC.

Article One

The aggregate number of shares which the corporation shall have authority to issue is 100, at no par value.

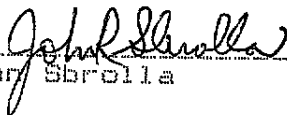
Article Five
