ARTICLES OF INCORPORATION
OF

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is The Great Gatsby Corporation.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 2881 Jefferson Street, Marianna, Florida 32446, and the mailing address of the Corporation is P. O. Box 138, Marianna, Florida 32447.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares.
