ARTICLE I

The name of the corporation shall be ENERGY CONTROL SPECIALISTS, INC. and its mailing address shall be 15515 NINETY FOURTH STREET NORTH, WEST PALM BEACH, FLORIDA 33412.

ARTICLE II

This corporation shall have perpetual existence commencing upon the filing date of these Articles of Incorporation with the Secretary of State of Florida.


