Operating Provisions

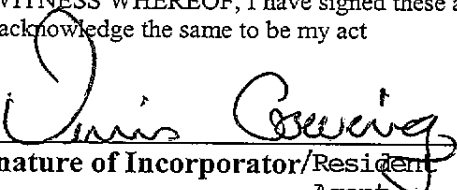
