ROAD SMART, INC.

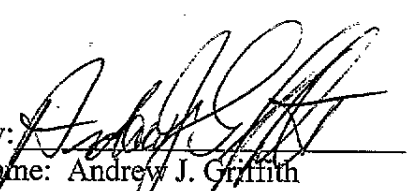

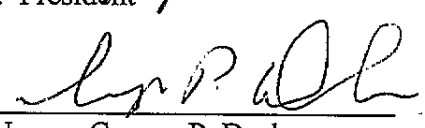
