BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of the corporation is EDM. Inc.
2. TERM. The corporation shall exist perpetually.
3. PURPOSE. The purpose of this corporation is to transact any or all lawful businesses for which corporations may be incorporated under Chapter 607 Florida Statutes.
4. CAPITAL STOCKS. This corporation is authorized to issue 1000 shares of common stock of a par value of \$1.00 a share.
5. REGISTERED AGENT. The initial registered agent for this corporation is Erik Kara and the initial registered office is located at 1368 East State Road 574, Seffner, Florida 33584.
6. DIRECTORS. This corporation shall have two directors initially. The number of directors shall be fixed by the bylaws and may be changed from time to time.

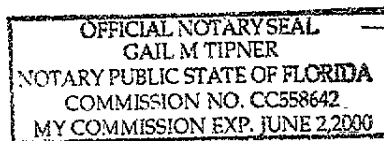


