**ARTICLES OF INCORPORATION OF
HOME123.COM, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for Home123.Com, Inc. (referred to herein as the "Corporation"):

ARTICLE I - NAME

The name of the Corporation shall be Home123.com, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - CAPITAL STOCK
