ARTICLES OF INCORPORATION OF HOME 123. COM, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation for Homel 23. Com, Inc. (referred to herein as the "Corporation"):

ARTICLE L-NAME
