

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be American Marketing Professionals, Inc. and its principal office address is: 29925 SW 172 Court, Homestead, FL 33030.

ARTICLE II. DURATION. This corporation is to exist perpetually.
