**ARTICLES OF INCORPORATION
OF
L/A FINE ART & COLLECTABLES, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is L/A FINE ART & COLLECTABLES, INC., and the principal address and principal place of business is 6589 HILLSIDE AVENUE NORTH, SEMINOLE, FLORIDA 33772.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI - AMENDMENTS


