ARTICLES OF INCORPORATION

OF

PASCO HMA, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

FIRST: The name of the corporation is **Pasco HMA, Inc.**

SECOND: The street address and the mailing address of the initial principal office of the corporation is 5811 Pelican Bay Boulevard, Suite 500, Naples, Florida 34108-2710.

THIRD: The number of shares the corporation is authorized to issue is 10,000.

FOURTH: The street address of the initial registered office of the corporation is c/o CT Corporation System, 1200 South Pine Island Road, City of Plantation, Florida 33324, and the name of its initial registered agent at such address is CT Corporation System.

SEVENTH: The purpose for which the Corporation is formed is to engage in any lawful act or activity for which a corporation may be organized under the Florida General Corporation Act provided that the Corporation is not formed to nor will it engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.


