# ARTICLES OF AMENDMENT AMENDED AND RESTATED ARTICLES OF INCORPORATION CEPEX USA, INC.

- 1. The name of the corporation is Cepex USA, Inc. (the "Corporation").
- 2. The Amended and Restated Articles of Incorporation of the Corporation

hereby amended to add a new Article XII to read as follows:

#### "ARTICLE XII Preemptive Rights

The holders of the common capital stock of this Corporation shall have proemptive rights to purchase, at such prices, terms and conditions as may be fixed by the Board of Directors of the Corporation from time to time, such additional shares of the common capital stock of the Corporation as may be approved for issue from time to time by the Board of Directors, whether for cash, property, or such other and further consideration as may be fixed by the Board of Directors. The preemptive rights of any shareholder shall be determined by the ratio of the issued and outstanding shares of the Corporation's common capital stock held by a shareholder immediately prior to the proposed issue and the total number of issued and outstanding shares of common capital stock of the Corporation which may be issued and outstanding immediately prior to the proposed issue."

The foregoing amendment was unanimously adopted by all of the shareholders of the Corporation pursuant to Section 607.1003(6) of the Florida Business Corporation Act. The
