First. The name under which this Corporation was formed is eBIZnet.Com Corporation. The name of the Corporation was changed to eBIZnet Corporation by an Amendment to the Articles of Incorporation duly filed on February 7, 2001 by the Secretary of State. The Articles of Incorporation were duly filed on the 25th day of May, 2000 by the Secretary of State of the State of Florida. (Document #P00000051622).

Second. Article 1, is hereby deleted in its entirety, and respectively replaced by the following:

Article 1. The name of this Corporation is:

Merge Media Inc.

Third. Pursuant to the provisions of Section 607.0704(1)(5) of the Florida Statutes, this Amendment was duly adopted on August 9, 2001 by the written consent of the holders of 4,950,000 shares of Common Stock, representing approximately 63% of the issued and outstanding Common shares entitled to vote thereon. Such number of votes represented by the written consent of shareholders was sufficient for approval.

Fourth. This second Amendment to the Articles of Incorporation shall take effect on the filing hereof by the Secretary of State of the State of Florida.
