**ARTICLES OF INCORPORATION
OF
SOUTH FLORIDA LAWN MANAGEMENT, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

NAME: The name of the Corporation is SOUTH FLORIDA LAWN MANAGEMENT, INC.

ARTICLE TWO

DURATION: The corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE THREE

PURPOSE: This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or is hereafter amended.

ARTICLE FOUR

DIRECTORS: This Corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than one (1). The name and address of the director is:

CAPITAL STOCK: The Corporation is authorized to issue One Hundred (100) shares of .10 cents par value common stock.


