ARTICLES OF INCORPORATION OF RSONBALL ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of

Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be RSonBall Enterprises, Inc.

Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 11175 Chester Lake Road West, Jacksonville, Florida 32256-3580.

Article III Capital Stock

- Section 3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is Seven Thousand (7,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

Section 6.1. Duration. This corporation shall exist perpetually.
