ARTICLE I. NAME

The name of this corporation is SOUTH SUMTER, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

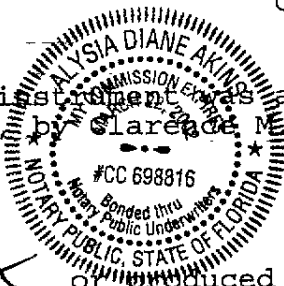
