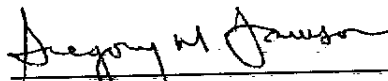
ARTICLE IX

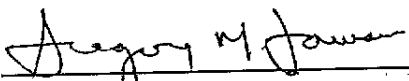

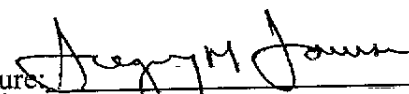
