ARTICLES OF INCORPORATION OF VICRAY PROPERTIES, INC.

THE UNDERSIGNED hereby associate ourselves for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

partnerships or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

- (f) To make contracts and guarantees and incur liabilities,
 borrow money at such rates of interest as the corporation may
 determine, issue its notes, bonds, and other obligations and secure
 any of its obligations by mortgage or pledge of all or any of its
 property, franchises, and income.




