There shall be no initial Board of Directors for this corporation, however the By-laws may provide for the establishment of a board of directors.

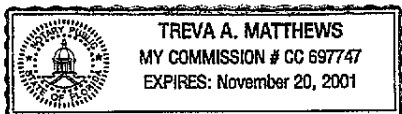
