ARTICLE I

CORPORATE NAME

The name of this Corporation is FEET FIRST REFLEXOLOGY, INC. The principal office and mailing address of the corporation is 2841 Citrus Lake Drive, K-101, Naples, Florida 34109.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

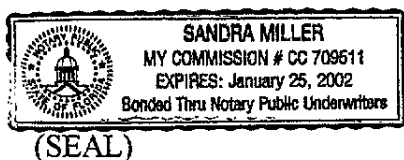


