

ARTICLES OF INCORPORATION

OF

DALE A. STOCKTON, D.M.D., P.A.



ARTICLE I

The name of the corporation ("Corporation") is DALE A. STOCKTON, D.M.D., P.A.

ARTICLE II

The existence of the Corporation shall begin on the date of filing these Articles with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 2900 Lake Washington Road, Melbourne, Florida 32935.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be



entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 2900 Lake Washington Road, Melbourne, Florida 32935. The initial registered agent for the Corporation at that address is Dale A. Stockton.

ARTICLE VI

ARTICLE VII

ARTICLE VIII

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE IX

This corporation is organized for the purpose of engaging in the professional practice of dentistry.

ARTICLE X

This corporation shall render professional service only through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services within this state; provided, however, this provision shall not be interpreted to include in the term "employee," as used herein, clerks, secretaries, bookkeepers, technicians, and other assistants who are not usually and ordinarily considered by custom and practice to be rendering processional services to the public for which a license or other legal authorization is required; and provided further, that nothing contained in this provision shall be interpreted to required that the right of an individuals to be a shareholder of this corporation is dependent upon the present or future existence of an employment relationship between him or her and this Corporation or his or her present or future active participation in any capacity in the production of the income of the Corporation in the performance of the services rendered by the Corporation.

ARTICLE XI

No shareholder of this corporation may sell or transfer his or her shares in the Corporation except to another professional corporation, professional limited liability company, or individual, each of which must be eligible to be a shareholder of the Corporation.

ARTICLE XII

The Corporation may not issue any of its capital stock to anyone other than a professional corporation, a professional limited liability company, or an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the Corporation is incorporated. No shareholder of the Corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of that person's stock.

ARTICLE XIII

The Corporation shall not engage in any business other than the rendering of the professional services for which it was specifically organized; provided, however, nothing in this provision shall be interpreted to prohibit the Corporation from investing its funds in real estate, mortgages, stocks, bonds, or any other type of investments, or from owning real or personal property necessary for the rendering of professional services.
