**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
NET WORKER CONSULTANTS, INC.**

Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation, **NET WORKER CONSULTANTS, INC.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

1. **Name of the Corporation.** The name of the Corporation is Net Worker Consultants, Inc.
2. **Text of the Amendment.** The amendment changes the name of the Corporation to Net Workers Consultants, Inc.

ARTICLE I - NAME

The name of the Corporation is Net Workers Consultants, Inc.

3. **Date of Adoption.** The Amendment was adopted effective June 1, 2000.
4. **Manner of Adoption.** The Amendment was adopted by the written consent of all of the members of the Board of Directors and by all of the shareholders of the Corporation. The number of votes cast for the amendment by the shareholders was sufficient for approval.
