# ARTICLES OF INCORPORATION OF LAWN ENFORCEMENT PROPERTY MANAGEMENT, INC.

#### Article 1

Name. The name of this Corporation is LAWN ENFORCEMENT PROPER MANAGEMENT, INC.

#### Article II
