**ARTICLES OF INCORPORATION  
OF  
LAWN ENFORCEMENT PROPERTY MANAGEMENT, INC.**

**Article 1**

**Name.** The name of this Corporation is LAWN ENFORCEMENT PROPERTY MANAGEMENT, INC.

**Article II**

**Principal Office:** The principal place of business and mailing address of this corporation shall be: 4802 S.W. 85<sup>th</sup> Avenue, Gainesville, Florida, 32614; mailing address: P.O. Box 141091, Gainesville, Florida, 32614-1091.

**Article III**

**Duration.** The period of duration of this Corporation shall be perpetual.

**Article IV**
