ARTICLES OF INCORPORATION

OF

LARUE FASTENING SYSTEMS, INC.



I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: LARUE FASTENING SYSTEMS, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS
