ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is GUARIQUITO PROPERTIES, INC. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

A. C. To purchase the corporate assets of any other corporation and engage in the same or other character or business.

D. 
