

ARTICLE ONE

The name of the corporation is **MILLENNIUM DIVERS, INC.** The principal address of the corporation is: 761 Tanglewood Circle, Weston, Florida 33327.

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE


ARTICLE EIGHT
