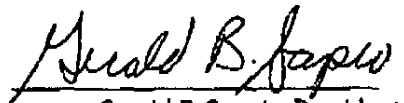
1. The name of the corporation is J & M Dairy, Inc. (the "Corporation") and was incorporated on June 1, 2000 under document number P00000053002.
