#### ARTICLE I. NAME

The name of this corporation is THE BEST GRILL AND BAR, INC., whose address is 806 North Shore Dr., Leesburg, FL 34748.

## ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the date of filing of these Articles of Incorporation.

#### ARTICLE III. DURATION

The term of existence of the corporation is perpetual.
