ARTICLES OF INCORPORATION OF CUSTOM RUG GALLERY, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of ELLED 119 Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be Custom Rug Gallery, Inc.

Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 1966 San Marco Boulevard, Jacksonville, Florida 32207.

Article III Capital Stock
